Dear Leader Schumer, and Ranking Members Feinstein, Murray, and Durbin:

As officers of the National Association of Immigration Judges (NAIJ) and the International Federation of Professional and Technical Engineers (IFPTE), the parent union of NAIJ, we recognize your leadership in safeguarding public health and occupational safety in response the COVID-19 pandemic and we urgently ask you to include a "sense of Congress" resolution in the next stimulus legislation that calls for the complete and temporary closure of all 68 Immigration Courts operated by the DOJ's Executive Office for Immigration Review (EOIR).

In our joint statement with the union representing the ICE Office of the Principal Legal Advisor attorneys (AFGE Local 511) and the American Immigration Lawyers Association (AILA), issued on March 15, we cited Dr. Ashish Jha, Professor of Global Health at Harvard School of Public Health. NAIJ consulted with Dr. Jha and asked him to consider the Immigration Court as a workplace setting and the nature of our hearings in light of the current state of the COVID-19 infection in our country. In the face of inadequate national testing, Dr. Jha said it is irresponsible to do anything other than close our courts until sufficient testing has been conducted.

NAIJ, AFGE Local 511, and AILA – three organizations representing those working in the Immigration Courts unified in our call for the temporary emergency closing of the Immigration Courts – are also joined by public defenders in New York City and organizations advocating on behalf of immigrant populations. As we speak in a unified voice, we are learning of attorneys who represent respondents and at least one Immigration Judge who are self-isolating and showing symptoms. Further, DOJ has acknowledged the danger that hearings present to public health and has postponed hearings on the non-detained docket and closed 11 of the 68 courts. However, DOJ has failed to provide a rationale for keeping Immigration Courts open for hearings on the detained docket as well as Migrant Protection Protocol (MPP) hearings. The Department's current response to the COVID-19 pandemic is disconnected from the needs and advice of community leaders and scientific experts.

The three organizations agree that critical court functions can be conducted through telework if the courtrooms are closed. Judges can address priority matters over the next two to four weeks through bond hearings conducted by telephone and email and with coordination between EOIR and CBP to ensure future hearings on the MPP docket resume in an orderly manner while public health officials and authorities assess, understand, and respond to the COVID-19 pandemic.

As we continue our call for the temporary emergency closure of the Immigration Courts in order to mitigate any further risk of COVID-19 transmission in our members' workplace, we look to Congressional leaders as advocates for workers and public health.
